General Business

McLoughlins Beach Ramp - Earlier reported through fishing magazines that funding was to stop for this launching ramp. This is not the case and Wellington Council have committed to funding this ramp for future years. Wellington council recognise the importance of this ramp and are looking at ways of enhancing the area, particularly dredging the channel. This will need a detailed assessment as sediment disturbed may be lethal to the environment.

Ian Brideson reported on his observance of Fisheries staff collecting Bass from the Avon River for use with their Bass stocking project. It is hoped that this will be an ongoing project and will help to replenish stocks of these slow growing fish for future years. Good to see money being spent on worthwhile projects.

Ray Clissold spoke about a call from Gippsport regarding a fishing day to be held at Lake Guthridge on 29th October. Students from Yarram High School will be there and it is hoped that some of our members can attend and demonstrate fly fishing techniques to the students. Several members will try and attend but as this is during office hours our attendance will be limited.

Discussion held regarding the late stocking of the Macalister catchment this year. It was decided that the Secretary should write to DPI requesting future fish stocking be planned for earlier in the winter months.
